A number of sources of information are used to assess candidates for the internship, including the written application and letters of recommendation. Following review of written materials, a skype interview is offered to candidates under consideration. We prefer applicants from doctoral programs in counseling psychology or clinical psychology. Stronger consideration will be given to applicants from APA accredited programs. Applicants should have a minimum of 500 intervention hours and 25 assessment hours on the APPI by the application due date. All coursework, practicum experience and comprehensive examinations required for the doctoral degree should be completed prior to internship. Applications are not considered complete until all materials are received.
